Dear Jeff and the EagleVail Board of Governors,

Thank you for the opportunity to present a funding request as part of your 2015 community funding cycle. Please accept the following as our funding outline for the Vail Valley Partnership & the Economic Council of Eagle County.

VVP's programs require both public and private support. Vail Valley Partnership is uniquely positioned to facilitate and actively engage entities throughout the valley and state in order to strengthen our community through our economic development, business support and destination marketing programs. Our day-to-day activities consist of connecting people to resources and entities to build community resilience and conditions favorable to business success. We strengthen regional economic vitality through our programs and efforts. We support local businesses. We unite key stakeholders. We lead collaborative efforts throughout the community.

## **Economic Development Goals and Objectives**

Our economic development plan targets 6 Core Objectives to position Eagle County's economy for long-term success and to achieve local area Economic Health.

### **Our 6 Core Objectives are to:**

1. Build a Business Friendly Eagle County
2. Create and Market an Eagle County Business Brand
3. Retain, Grow, and Recruit Businesses
4. Protect our Natural Environment
5. Expand Opportunity in our Leading Sectors (Tourism & Recreation, Health & Wellness and Creative Industries)
6. Provide Support for a Quality Workforce (Affordable Housing, Education, Transportation, Health)

We expect our collective efforts to contribute significantly to these goals for Eagle County stakeholders (including the Community of EagleVail) with financial support from Eagle County, individual municipalities, unincorporated communities and the business community. These goals align with EagleVail's goals to support the business center and the business community and to support the continued development of the Eagle Valley trail system.



Work is underway in the following areas:

**1. Designing and implementing a Business Retention & Expansion program (BRE)**

This will build a proof point of a business friendly community through a coordinated network of communication and action. This will be a formal program that will effectively listen to local businesses needs and will act on what is heard.

**2. Creating and Marketing an Eagle County Business Brand**

Brand development is underway and the language of that brand will be communicated to our targets via a new countywide business development website. The Eagle County business brand will be designed to enhance and leverage, not compete with, individual brand identities.

**3. Move toward Active Business Recruitment**

Once a solid outward facing marketing strategy is developed, we will, for the first time as a region, have the ability to pursue 'active' business recruitment, rather than the passive recruitment to which we are limited today.

The Partnership recognizes that our community is made up of several unique municipalities and a number of unincorporated areas; however, we are interconnected from a business standpoint and a community viewpoint. Every effort is made to be collaborative in our programming and to offer benefits to help businesses succeed.

Community programming provides access and opportunities for business growth, supporting the EagleVail business district and businesses throughout Eagle County, and include:

1. Economic Council of Eagle County
2. Lodging Quality Assurance Program
3. Vail Valley Merchant Alliance
4. Vail Valley Sports & Event Coalition
5. Vail Valley Health & Wellness Initiative
6. Non-Profit Network and Vail Valley Volunteer Connection
7. EGE Air Alliance (administrative support)

VVP hosts a variety of educational & networking events targeting the business community; over 40 such events will be hosted in 2014.

Additionally, the Partnership's destination sales & marketing efforts (including group sales, event recruiting and leisure sales) resulted in an economic impact of \$74,000,000 in 2013, contributing over \$4.5m in local and state tax revenues. VVP is the only regionally focused destination marketing organization in the valley, working with stakeholders such as the Colorado Tourism Office to ensure all communities (including EagleVail) are represented in state tourism promotion.

VVP produces Visit Vail Valley – the Official Visitors Guide and manages VisitVailValley.com, which includes robust tourism information for all communities within the valley. These tools also include a valley-wide calendar of events and business listings.



## 2015 Funding Request

Our regionally focused economic development efforts include a variety of business-focused community programming and ensures local representation at, and active participation in, various regional and state-wide forums including the Northwest Colorado Council of Governments economic development district, Colorado Rural Workforce Consortium, Colorado Innovation Network, Colorado Office of Economic Development & International Trade, Colorado Tourism Office, and various regional planning sessions and coalitions.

This participation ensures Eagle County community interests are represented in an active and professional manner and ensures local facilitation and coordination of economic development efforts. Moving forward the Partnership and Economic Council will continue to:

- Generate positive economic conditions in Eagle County through implementation of the Economic Development Plan - a plan that will deliver a network of community business support resources to retain & grow existing businesses - and an outward facing marketing strategy to attract additional business development.
- Forge strong relationships between the various segments, both geographic and within key industries, within the business community and key stakeholders
- Provide economic information (research) to stakeholders to assist in data driven decision-making.
- Represent Eagle County stakeholders and business community interests to regional & statewide organizations and provide local facilitation of economic development activities.
- Promote all communities in the Vail Valley through VisitVailValley.com, including a valley-wide regionally focused calendar of events, and through Visit Vail Valley – Official Visitors Guide.
- Promote your community as an engaged stakeholder via destination marketing, chamber of commerce programming and economic development efforts to build your brand in the community.

## **2013 Eagle County Economic Development Plan Quarter 1, 2014 Implementation Status Report**

### **Executive Summary**

#### **2013 Eagle County Economic Development Plan Background:**

To promote the long-term economic health of Eagle County and solidify an economic base that is strong, diverse, and resilient our communities must:

1. Retain and expand current businesses and;
2. Recruit new businesses.

This plan targets 6 Core Objectives to position Eagle County's economy for long term success and to achieve local area Economic Health.

The 2013 Eagle County Economic Development Plan defines "Economic Health" as:

- Strong, sustainable growth of individual incomes and sales tax revenues
- Healthy population growth
- Increased business longevity
- Diversification of industry for year-round availability
- Job opportunities with promotional potential
- Viable business opportunities for entrepreneurs

Progress towards these ends will be measured through specific growth targets for Average Weekly Wages, Average Yearly Earnings per Job, Net New Jobs, Sales Tax Collections, County Population Growth, Unemployment Rates, an Economic Stress Score and the Assessed Values of commercial properties.

The Eagle County Economic Development Plan is intentionally collaborative in nature and is designed to supplement and support (not replace) municipal level economic development efforts, providing a tie to countywide, regional and state-level activities.





### **Quarter 1, 2014 Implementation Overview and Key Accomplishments:**

The 2013 Eagle County Economic Development plan was approved and adopted by the Board of County Commissioners in late December of 2013. The BoCC awarded a community grant to Vail Valley Partnership to lead a countywide implementation effort. Municipalities and special districts in the Eagle River Valley also voiced their approval by providing additional financial support to the implementation effort for 2014. Thank you all for your support!

Vail Valley Partnership began 2014 by building a detailed quarterly work plan to guide the implementation of the plan throughout the year and set loose milestones for work in 2015 and beyond.

The first two core objectives of the plan are "Build a Business Friendly Eagle County" and "Create and Market an Eagle County Business Brand." The VVP views these as two objectives as foundational elements that lay the groundwork for economic and business development success in our county. If the first two core objectives can be achieved, we can say with credibility that Eagle County (and it's collection of unique, individual communities) is indeed 'open for business' and move ahead with clearly defined strategies to accomplish our other four core objectives.

### **All targeted 1<sup>st</sup> quarter deliverables have been completed (as tied to the 6 Core Objectives) for Quarter 1, 2014:**

#### **1. Build a Business-Friendly Eagle County:**

- a. Met with all Eagle County (valley) communities regarding economic development plan, inquired about interests and how to best complement efforts.
- b. Previewed major 1<sup>st</sup>-step regional ED topics with partners including collaborative working agreement, universal business license application, & business retention program ideas.
- c. Developed a scope of work for economic development research & data collection for 2014 and deadlines for all deliverables.
- d. Held 1:1 discussions with all members of Economic Development Leadership Council (citizen advisory group) updating them on implementation efforts & gained interest from a few new individuals.
- e. Received commitment from the Vail Board of Realtors & the Vail Multi-List Service to allow direct import of local area commercial real estate data into our Regional InSite (commercial real estate) program.
- f. Loaded InSite on VailValleyPartnership.com economic development pages via iFrame (this will be integrated into new website.)
- g. Authored & delivered collaborative sign-on letter to the Eagle County congressional delegation voicing support for continued (and permanent) funding for the Payment in Lieu of Taxes (PILT) program.
- h. Monthly delivery of "Eagle County Economic Snapshot" report available at: <http://bit.ly/1mQzlm9>



**2. Create and Market an Eagle County Business Brand**

- a. Conducted research on national trends in community business branding, marketing approaches and web development practices to inform development of RFQ for a branding and web development projects.
- b. Branding and web development RFQ's were developed and released for public bid on March 31<sup>st</sup>. Responses are due April 21, by 3:00pm.

**3. Retain, Grow, and Recruit Businesses**

- a. Responded to 5 business leads (Real Estate Developer, Manufacturing Interest, Restaurant Venture, Technology Company & National Quick Service Restaurant Chain) requesting support for decision making on potential local area business starts.
- b. Conducted research into western Eagle County community eligibility for the Colorado Enterprise Zone program. The program offers businesses in 16 mapped zones state-wide, access to 8 distinct state tax credits to incentivize job growth. After initial excitement, the opportunity appears limited. Discussions are ongoing.
- c. Promoted local business support tools via a new monthly "Business Resources" feature in VVP e-Newsletter.

**4. Protect our Natural Environment**

- a. Continued promotional efforts of Actively Green 2015 through VVP communications channels.

**5. Expand Opportunity in our Leading Sectors (*Tourism and Recreation, Health & Wellness, and Creative Industries.*)**

- a. Maintained and extended robust engagement with key partners including: CTO, TIAC, CADMO, EGE Air Alliance, Vail Resorts, VVF, OEDIT & others.
- b. Represented Eagle County interests at "Tourism Day at the Capital."
- c. Convened and jointly-hosted with NWCCOG, "Healthy Economy, Healthy Colorado" - a discussion of the state's Health and Wellness Industry Strategic Plan and a local area industry panel highlighting challenges & opportunities in 4 distinct segments of the sector locally.
- d. VVP has partnered with the Healthy Communities Coalition to promote Health Links, a new workplace wellness certification & capacity building program operating in Eagle County that that is making up to \$100,000 available to Eagle County businesses with under 50 employees (and other eligible counties) to implement wellness practices in the workplace
- e. Convened local arts & culture organizations to explore pursuit of a regional Creative District designation. The regional effort was tabled because research indicated community-level applications would be most competitive. As a result, Town of Avon submitted a letter of interest and was selected as 1 of 11 communities statewide to be invited into the second-round of the Creative District selection process.



- 6. Provide Support for a Quality workforce (*Affordable Housing, Education, Transportation, Health*)**
  - a. Discussions on local workforce training needs with Colorado Mountain College President.
  - b. Met with local business owners and a venture capitalist to discuss business growth in the valley. Primary concerns: labor force talent & aggregation and local healthcare costs.
  - c. Consultation & collaboration with the Eagle County Housing Department on revisions of Affordable Housing Guidelines and related Administrative Procedures.
  - d. Business community participant in Eagle County Public Health's creation of a Health Equity Road Map for Eagle County.
  - e. Promoted local business support tools via a new monthly "Business Resources" feature in VVP e-Newsletter.
  - f. Health Links program promotion in Eagle County.
  - g. Joined Colorado Mountain College Edwards campus Advisory Council

**Next Steps:**

1. Retain branding/web agency(s)
2. A facilitated business branding process (encouraging engagement from all public and private partners) likely to begin in May.
3. Begin "Regional Economic Development Working Agreement" conversations in earnest. Poll for feedback, shop around draft language/ideas.
4. Request business license applications from all towns and begin sorting through the process to determine feasibility.
5. Discuss town level appetite/capacity to respond to a BRE program. If interest exists, VVP will design a survey and administrative process for collecting reliable business retention data.
6. Recruitment of additional EDLC (private participants) to add depth and perspective to the input we are hearing as we continue to implement this plan.
7. VVP will conduct a comprehensive inventory of business support resources available at the local and regional level to build into future website content.
8. Delivery and/or administration of all relevant Quarter 2 data products including: Demographic Report, Labor Force Report, Workforce Survey, Monthly Economic Indicator Reports

## **Quarter 2, 2014: Implementation Overview and Key Accomplishments:**

Vail Valley Partnership pushed the implementation process ahead in the second quarter of 2014 by focusing the majority of its efforts on the first two core objectives of the plan. The goals to "Build a Business Friendly Eagle County" and "Create and Market an Eagle County Business Brand" are seen as foundational elements that lay the groundwork for economic and business development success in Eagle County. With a strong foundation the other four core objectives can be strategically and comprehensively tackled from a place of credibility.

Primary accomplishments in Q2 include the hiring of a branding agency (Cubic Creative) to lead the business branding and web development projects. The brand development process began in early June with the VVP engaging 58 Eagle County residents to participate in 8 community focus groups led by Cubic. Participants represented many geographic points in Eagle County and brought a variety of ethnicities, perspectives, ages and social categories to these discussions. Sessions were held in Gypsum, Eagle, Avon and Vail. Cubic also toured each community and visited with additional residents, business owners and visitors during their ethnography visit. Cubic plans to report back its initial findings in early August.

The VVP also participated in an International Economic Development Council Business Retention and Expansion course and has taken its learnings and developed a prototype Business Retention & Expansion Program (BRE), which will be the first of its kind in Eagle County. A quality BRE program will provide a functional proof-point of our region's 'business friendliness,' assuming proper implementation, and is the most cost-effective and impactful economic development strategy available to any community. The VVP will continue to tweak its program design and begin implementation of this BRE program in Q3.

This development of a BRE program also brought the light the necessity for slight course changes in the timing and application of our efforts as we've gained knowledge. The VVP has decided to postpone the pursuit of a formal regional economic development working agreement between community partners until the BRE program and countywide economic development website and business brand are functioning and underway. We believe this will be a simpler and more relevant task once local partners can see a tangible picture of what a highly functional collaborative economic development effort can do for our communities.





**All targeted 2<sup>nd</sup> quarter deliverables (as tied to the 6 Core Objectives) have been completed and/or modified based on learnings gained through the implementation process thus far:**

**1. Build a Business-Friendly Eagle County:**

- a. The VVP maintains regular communication with its lead partner through monthly meetings with the Eagle County Economic Vitality workgroup and through recurring study sessions with the BOCC. The VVP recognizes that proper communication is foundational to the ultimate success of this effort.
- b. Gained a framework, knowledge and tools for designing and implementing a retention and expansion (BRE) program to serve Eagle County.
- c. Initial BRE program design is complete, with first-stage implementation to occur in Q3.
- d. Completed and released scheduled economic indicator reports and data deliverables including: 2014 Economic Indicators and Demographics report, monthly economic 'snapshot' reports, and a 2013 year-end Foreclosure Report.
- e. The 2014 Workforce Survey has been administered and data analysis and final report development are underway.
- f. VVP is currently assessing the feasibility of a Universal Application for Business Licensure to unify multiple business license processes into one online process. Early indicators suggest such an idea may further complicate processes for business customers rather than improving them. We will know more on this subject in the near future.
- g. VVP continues to build engagement with Eagle County Schools by exploring relationships between high-performing schools and a strong local economy.

**2. Create and Market an Eagle County Business Brand**

- a. Received 6 proposals in response to the business branding and web development RFQ's released in late March.
- b. Selected Cubic Creative as the firm to lead the business branding and website development projects.
- c. Engaged 58 Eagle County residents in the Eagle County business branding effort via 8 focus group sessions held in Gypsum, Eagle, Avon and Vail.
- d. Cubic plans to present its initial findings back to the VVP in early August.

**3. Retain, Grow, and Recruit Businesses**

- a. Developed and delivered a best practice guide on the use of Economic incentives to the Town of Eagle and Eagle County Government to inform their consideration of incentives offerings for business development.
- b. Responded to a number of business relocation and expansion interests including a gluten-free baking mix company, a hotelier, a health and wellness interest, and an existing Lionshead-based retailer exploring local manufacturing. All requested data and local area knowledge to inform decision making on potential business starts and/or expansions or process changes.
- c. VVP coordinated with Eagle County Regional Airport to research speculative Foreign Trade Zones and provide background input to the towns of Gypsum and Eagle regarding a party promoting the concept locally.
- d. Promoted local business support tools via our monthly "Business Resources"



feature in the VVP e-Newsletter.

**4. Protect our Natural Environment**

- a. Met with local environmental programs and agencies to learn 2014 goals, share county-wide economic development goals and engage some of them in the Eagle County business branding process.
- b. Continued promotional efforts of Actively Green 2015 through VVP communications channels.

**5. Expand Opportunity in our Leading Sectors (*Tourism and Recreation, Health & Wellness, and Creative Industries.*)**

- a. The VVP promoted Colorado.com business listing availability to all business members and contacts associated with the Vail Valley Merchant Alliance.
- b. Hosted site visits from Iceland and Japan in conjunction with the Colorado Tourism Office.
- c. Updated all community (municipal and metro district) web pages on [vailvalleypartnership.com](http://vailvalleypartnership.com) with new content and links to appropriate websites.
- d. The VVP has provided design specs to our web developer to improve the functionality of a regional calendar of events on [vailvalleypartnership.com](http://vailvalleypartnership.com) and [visitvailvalley.com](http://visitvailvalley.com). An online system is being developed that will allow for self-managed content management.
- e. The VVP and the Vail Valley Foundation are holding quarterly joint-educational events prior to VVP's traditional After Hours Business Mixers to drive awareness and engagement with respect to the 2015 World Alpine Ski Championships and its opportunities and impacts.
- f. VVP provided lead facilitation services to NWCCOG's Regional Health and Wellness Sector Partnership launch meeting held in June. A follow-up meeting is scheduled for September to address the underutilization of low cost preventative services that have the potential to drive down regional workers comp costs, health insurance costs and increase workforce engagement and retention.
- g. VVP added HealthLinks as a "Partnering Program" and is incentivizing VVP member program participation through a 30% discount in annual program fees.
- h. The VVP is providing leadership on the issue by pursuing HealthLinks certification itself.
- i. Provided support to the Town of Avon's application to become a "Creative District in Training" through the Colorado Creative Industries Creative District program via a supporting interview and letter of support to their application.
- j. Coordinating with Nate Walowitz, and NWCCOG on regional broadband issues facing Eagle County (and Red Cliff in particular). VVP referred Public Access TV5 to NWCCOG to share their experiences with broadband inadequacies as a heavy user of dependent technologies.
- k. VVP and Vail Leadership Institute are hosting a quarterly leadership educational series throughout 2014 to bring leadership education to local businesses and entrepreneurs.





- 6. Provide Support for a Quality workforce (*Affordable Housing, Education, Transportation, Health*)**
- a. Developed a new BRE program design that will proactively engage community support partners and make their services more visible and available to meet both employer and workforce needs.
  - b. Provided support to Town of Gypsum's Citizen's Institute on Rural Design grant application.
  - c. Cubic Creative was instructed to take into account local workforce strengths to inform elements of the community business brand development.
  - d. A "Business Resources" feature continues to run on a monthly basis in the VVP e-newsletter. In Q2, VVP highlighted the NW Loan Fund, Town of Vail's Storefront Incentives Program, Colorado Creates grant opportunities, and Colorado Mountain College Customized Business Service offerings among others.

**Next Steps:**

- 1. Completion of community business brand development and outward facing marketing strategy.
- 2. Initiate the build out of a new regional economic development website.
- 3. First-stage implementation of newly developed Business Retention & Expansion (BRE) program.
- 4. Complete study into the feasibility a 'Universal Application for Business Licensure.' Early research indicates this may create more problems than it solves. If so, this idea will be tabled.
- 5. Delivery and/or administration of all relevant Quarter 3 data products including: 2014 Workforce Survey, Housing Affordability Study, Monthly Economic Indicator Reports.

### **2014 Community Survey Results**

This is a report on the results of this year's Community Survey.

#### **Background**

This is the second Community Survey since 2012. It was offered for approximately the first three weeks of April 2014.

## EagleVail Community Survey (2014)

### Key Observations

- **Right Direction:** 2014 results remained virtually unchanged from 2012. The majority of survey participants responded that EV is going in the “**right direction**”, while those who feel as though EV has “**gotten off track**” has fallen slightly.
  - Comments seem to be most critical of poorly maintained properties, dogs running at large (and dog poop) and a concern that a small group of active people are making improvements that only they enjoy.
  - Positive comments are centered on the “look” of EV and the improvements.
- **Sense of community:** Positive results are virtually unchanged from 2012, with 56% believing that it has improved, while 6% fewer respondents think it’s stayed the same.
  - Several of the comments suggest spending less money and have fewer events. This may be a good opportunity to point out that many of the activities are “turnkey” events that we support, but do not pay for. The Turkey Trot and Harvest Party/Chili Cook Off are good examples of this.
- Respondents are still most satisfied with **EV hiking trail**. It is followed by the **pool, entry monuments, new street signs, new logo, ECO Trail and Power Line Burial** in satisfaction. The **golf course** and **Traffic Calming** continue to receive the least satisfaction ratings. The **Community Garden** ratings showed the biggest single movement—from a 44% positive to almost 61%. The percentage of those who have favorable ratings for the maintenance and cleanliness of the **pocket parks** increased significantly.
  - Many of the negative comments are focused on “big government” and “control”. Many of these comments are linked to the various traffic calming efforts. Ironically, there are many comments that complain about speeders, too, and ask for more traffic control measures, i.e., speed bumps.
  - Extension of trails and sidewalks appears to be popular.
- Use of the **18 hole Golf Course for other than golf** is the number 1 use of our amenities, showing that open space that people can use is critical to their quality of life. Other well-used amenities are the **hiking trail, pocket parks, Nordic trails and swimming pool**.
- Of those who don’t use our amenities, more than 40% said they just didn’t have time, while those who prefer other recreation providers and price followed at 23%. 15 % said they didn’t find anything they’d like to do and 14% weren’t aware of the offerings.
  - There are many comments to the effect that property owners should have deeper discounts on amenity use, especially golf and the pool.







- 70% liked the idea of **extending the EV Trail**, 60% support pursuing a **Chairlift** and 43% support **Highway 6 beautification**. 40% don't feel the **Community Clubhouse** development is a priority, while the establishment of a **Post Office or Cluster Boxes** gathers equal ratings for both high and low priorities. Almost 50% of respondents thought improving the **Tennis Courts and Tennis Building** was a lower priority.
- 74% of respondents said they were excited or very excited about the vision for the new and improved EV, while around 10% were not so excited.
- In a new question for 2014, we found that 33% of folks would pay \$100 a year more to **Make Improvements in EV**. The news here is that 75% of respondents said they would be willing to pay more. 15% said they would pay \$400 or more annually.
- Respondents are satisfied, to the clip of 65% with **Communication from the BOG** to members and the public. The ratings show an overall favorable rating of 53% for the BOG.
- The top priorities for our Covenant Enforcement Officer to concentrate on are **trash cans not bear proofed, yard waste, dogs running at large, properties needing repair/paint and rec vehicles parked in driveways**. Only the trash related items above received more than a 50% rating. **Dogs being walked without leashes** is not a priority, as rated by 49% of respondents. This number went up rather significantly, from 44%. It may be our increased efforts to educate folks that leads to this change. 33% thought leashes were important.
  - The dichotomy in Covenant Enforcement: many service requests and many comments of "heavy handedness".
- 54% of respondents get information about EV happenings from the **newsletter**, while **eBlast! and email** are also popular options.
- The survey indicates that 75% of respondents are **full time, year-round residential owners**, while about 18% identified themselves as **part time owners**. 5% own property, but don't live in EV at all and 2.5% identify themselves as renters.
- Survey respondents report that 2.89 people are part of each household, 41% say that they are a couple with kids at home, 60% have lived in EV for longer than 10 years and 80% are actively employed.
- Frequent comments received as part of the survey express concerns about the **cost of taxes and dues**. It also appears that many residents may not understand that the bond funds were voted on for specific purposes by the voters of EV.
